Celebrations

Completed Matters

- 1. **Tech** New acoustic baffles have been installed on the ceiling in the sanctuary. This should improve sound quality for services and concerts.
- 2. **Kitchen** The Knox kitchen was inspected by the Environmental Health Officer and was found to be in order. Martha Pow has retired from her responsibility for taking care of the kitchen. Her replacements are Myrt Omnes and Jeanette Mossing.

Calendar of Events

- 1. **Fire Inspection** The Parksville Fire Department completed their annual inspection in early April. The final report was received on November 1. A new lockable *Fire Safety Plan* box has been installed. We also received new occupancy limit signs for the sanctuary, chancel and lounge. Frames have been ordered and the signs should be posted within the next month.
- 2. **Parking Lot** –New staff parking and handicap parking signs have been purchased and should be installed within the next month.

Concerns

- 1. **Kitchen Range** There have been intermittent reports of problems with the kitchen range.
- 2. **Front Door** Repair has been arranged on the locking/closing mechanism on one of the front doors. In the meantime, it is being left locked when possible.
- 3. **Sanctuary Audio** There have been ongoing problems with audio quality in the sanctuary which seem to originate in cabling under the chancel. A new audio "snake" has been purchased and installed temporarily. More permanent routing of the new cable is in progress.
- 4. **Sanctuary Video** The tech group is investigating video quality issues for the two main (chancel) projectors.

Costs

Coming Up Matters

- 1. **Fire Drill** We were unfortunately unable to complete the required annual fire drill this year. The fire department has okayed deferring it until spring as long as it is completed before the end of April. W&A has scheduled the fire drill for April 26.
- 2. **Knox Sign** Sacred Spaces has started to work with Communications to investigate a new sign for Knox. One of the initial steps is a survey to identify needs and priorities. Most ministry and staff survey forms have now been received. Two members of the congregation have contributed a significant amount of money to support a new sign.
